This year Prevent Child Abuse North Carolina helped local agencies adjust to the impacts of the COVID-19 pandemic. We prioritized strategies in response to COVID-19 by helping agencies pivot to virtual service delivery, adapted resources for agencies who support parents, and advocated for policies that help strengthen families. These key child abuse prevention programs teach strategies for handling challenges, understanding developmental

Toolkits, awareness campaigns, parenting brochures, statistics and research, and skill building tips are provided to all 100 counties and over 85,000 organizations and individuals across the state. Information is provided to all interested citizens in regard to accessing parenting support in local communities, training on the Protective Factors is provided and we provide free web-based training on how to recognize and respond to child maltreatment.
